GDPR – General Data Protection Regulations

The Association GIO – Global Indian Organisation is concerned about the protection of personal data. We are committed to ensuring the best level of protection for your personal data in accordance with applicable law and the "General Data Protection Regulations".

Data Processing Controller

The personal data collected on the GIO - Global Indian Organisation website (www.globalindianorg.com) or Memberships documents are recorded in a computerized database and under the control of our GIO Media and IT Team.

Purposes of processing

The personal data collected is used for the GIO membership management, management of comments on blog or website, Facebook, Youtube, Whatsapp, Twitter, Instagram, sending emails of responses to contact forms, sending emails for events and sending of newsletters by email (offered only by GIO-Global Indian Organisation).

Certain data is collected automatically as a result of your actions on the site in order to carry out audience measurements (the number of pages viewed, the number of visits to the site, the products consulted, etc.) or are necessary for prevention and the resolution of technical incidents (lost password).

Data collected

The personal data collected and processed are in particular your name, first name, title, email, password, telephone number, IP address, postal address, avatar, nickname, website, connection data.

We undertake to collect only the minimum data necessary for the proper functioning of the service provided by our GIO organisation. The mandatory or optional nature of the data collected is indicated to you when entering it by a mention "Mandatory" (or any other appropriate visual indicator such as an asterisk or an element in bold) or "Optional".

The period of data retention

The data is kept for the duration of use of the service and is then archived for an additional period in connection with the periods of limitation and legal retention for reasons strictly limited and authorized by law (payment, guarantee, disputes, etc.).

After this period, they are deleted.
